Information Technology Business In Poland

Poland's IT sector is experiencing robust growth. By 2025, the IT services market is projected to generate approximately **\$10.44 billion USD in revenue**, with IT outsourcing contributing around **\$3.84 billion USD**. The industry is expected to maintain a compound annual growth rate (CAGR) of **5.91%**, **reaching about \$13.14 billion USD by 2029**.

The broader Information and Communications Technology (ICT) market in Poland is anticipated to reach **\$31.59 billion USD in 2025**, with projections indicating growth to \$51.23 billion USD by 2030, reflecting a CAGR of 10.15%. Revenue from IT outsourcing is also expected to increase to **\$5.4 billion USD by**

2029, which is 54% more than in 2024.

Poland is home to a thriving tech ecosystem, with over 100,000 IT and tech companies, including approximately 50,800 focused on software development. The IT sector currently contributes around 3.5% to Poland's GDP, with projections indicating growth to 4.5% by 2025.

The broader ICT sector employs around 550,000 professionals, covering a wide range of roles in IT services and related fields. Reflecting its commitment to innovation, Poland ranks 40th out of 133 countries in the Global Innovation Index 2024.

Low Taxation

Poland offers one of the most competitive corporate tax rates in the EU, with a reduced 9% CIT for small businesses earning up to €2 million annually, and a standard 19% CIT for larger companies.

Poland is a leading IT outsourcing hub in Central and Eastern Europe (CEE). Poland is home to successful tech firms such as DocPlanner, Brainly, and CD Projekt RED, highlighting its robust tech environment.



Low Cost of Living

The cost of living in Poland is relatively low compared to Western Europe, with average monthly expenses (including rent) for a single person around \$1,197. Despite the lower costs, Poland offers a high quality of life, with access to excellent healthcare, education, and public services.
